5. Tax Rate 2024 (Motion #2024-10)

WHEREAS - in accordance with MGA (160) (1) (A) Non-Commercial Properties Tax Rate will be raised from \$0.50 per \$100.00 of assessment to \$0.75 per \$100.00 of assessment, and

WHEREAS Commercial Properties Tax Rate will be raised from \$0.55 per \$100.00 of assessment to \$0.95 per \$100.00 of assessment to raise revenue sufficient to defray projected municipal expenditures for this year including any deficit carried forward from the previous year,

BE IT RESOLVED - CAO Alana Searle will notify the Provincial Tax Commissioner in accordance with the Real Property Tax Act respecting the approved tax rate(s). Motion carried (4-1).

- 6. Sewer and Water Rate 2024 In accordance with MGA Section (153) Deficit prohibited. Council will raise existing Sewer Rate of \$385 per household by \$100 in 2024, an additional \$50 per household in 2025 and \$50 per household in 2026. Water Rate will be increased by 20% in 2024. Item deferred to next Council Meeting scheduled for March 19, 2024.
- 7. Bylaw Water & Sewer Corporation #2022-03 It was brought to the attention of council that a First Reading of Bylaw #2022-03 was presented for the first time June 21, 2022, but due to Official Trustee taking over in July of 2022 it did not have a Second Reading nor was it Approved and Adopted by Council. CAO Alana Searle will review previous bylaw "Establishment of Crapaud Sewage Collection and Treatment: 1988-06-06" and Bylaw #2022-03 and advise council of updates/changes at Council Meeting March 19, 2024.
